DXi-WIFI-EXP WiFi Kit *Installation Guide*



Introduction

The DXI-WIFI-EXP kit allows the Toro DXi irrigation controller to communicate with the Central via wifi. This document illustrates how to mount the wifi kit in the following DXi base models:

- DXI-PWM08
- DXI-PWMTW
- DXI-SWM08
- DXI-SWMTW
- DXI-SPED08
- DXI-SPEDTW

- DXI-SPEDHY08
- DXI-PSB08
- DXI-PSBTW
- DXI-DPSB56

Note: The WiFi module is compatible with 802.11 (b,g,n) networks only.

Kit Components

- one (1) wifi modem attached to DXi comm expansion board
- wifi antenna
- wifi antenna cable

- mounting screws
- stand-offs

Installation Instructions








CAUTION: Power off the controller prior to installing expansion kits.



Remove screws and cover.




Connect WiFi COM board to hardwire COM board.



The WiFi antenna has two identical connectors, both of which need to be connected.

The first connector connects the wifi antenna to the SMA connector on the docking COM board.

The second connector is not used but is recommended to still connect to secure the extra antenna cable.



Reattach the cover and secure with screws.



WiFi uses unlicensed spectrum in the 2.4GHZ

band. The network ID has to be entered into the controller faceplate under SETUP menu of the WiFi network. A password for the network would also be required. It is not advised to use a WiFI network without a password or a default unsecure password. Once the network is configured, the internet connection is established and a "CLOUD ID" is displayed on controller faceplate.

Antenna Installation

To install the DXi wifi antenna:

- 1 Insert antenna wires and threading through the hole (Figure 8).
- 2 Connect wire connectors to connectors in step 3 page 1.



For plastic pedestal, the wifi antenna is installed into a cutout in the lid (**Figure 9**).





Setup WiFi Network using a USB Drive

As a convenience feature, it is possible to setup certain WiFi network parameters using a properly configured USB drive. This eliminates the need to enter the network parameter information using the controller's keypad.

The commands are entered by typing them into a text file which will be saved to the USB drive.

There are three relevant parameters set by commands as shown:

SSID – the network name

To set the SSID, enter the command "wifissid ssid name" (without quotes).

To blank the value, enter the command "wifissid /b".

Example: If your SSID is "toroguest", the command to type is "wifissid toroguest" (without quotes).

Password – the network password

To set the WiFi network password, enter the command "wifipassword password" (without quotes).

To blank the value, enter the command "wifissid /b".

Example: If your password is "bob1234", the command to

type is "wifipassword bob1234" (without quotes).

Encryption Type - 0=none, 1=WPA, 2=WPA2, 3=WEP

To set the encryption type, enter the command "wifiencryption type" (without quotes).

Example: If no encryption is used, the command to type is "wifiencryption 0" (without quotes).

Steps:

- 1. Create a text file called **insert.bat**.
- Edit the file to contain the 3 commands, each on its own line of the file. For the examples above, the file would contain the following 3 lines:

wifissid toroguest wifipassword bob1234 wifiencryption 0

- 3. Save the insert.bat file to the root of your thumb drive.
- 4. Insert the USB drive into the controller. The commands will be executed.
- 5. Verify the settings using the controller's UI.

FCC & IC Label

It is important to keep track of what wireless devices are installed in your DXi controller.

Each DXi controller ships with a label showing important information such as Model number, Serial number, UL certification, and more 1.

Depending on the enclosure, this label might be found on the interior side of the enclosure door **2**.

- If your DXi controller ships with a wireless device, the label will show the FCC ID and IC ID 1.
- If your DXi controller does *not* ship with a wireless device, the label will be blank in that area.

The wifi kit ships with a small sticker label with its FCC ID and IC ID 3.

- If your DXi controller label is blank in that area, adhere the FCC sticker to that blank area.
- If your DXi controller label already has FCC ID and IC ID information in that area, adhere the FCC sticker adjacent to it as illustrated 4.


