Installation Instructions



CAUTION: DXi serviceable parts shall be installed by qualified personnel familiar with the product and with local electrical code requirements. DXi serviceable parts shall not be used or installed in product other than DXi Product Series. Failure to do so will void product's safety and FCC certification. If used in product other than DXi Product Series, additional safety and FCC testing shall be considered as part of the end product assessment and usability.

CAUTION: Power off the controller prior to installing expansion kits.





The cellular antenna has two identical connectors, both of which need to be connected.

The first connector connects the cellular antenna "Main" connector to the SMA connector on the docking COM board.

The second connector is connected to the remaining port. It makes no difference which connector is connected to which port--they are identical.



Reattach the cover and secure with screws.



The cellular modem comes pre-configured with a SIM card. The SIM card has been provisioned on the Sprint/T-Mobile network. Upon power up, the cell modem will automatically search for and register on the wireless network. From there, it will obtain its "CLOUD ID".

Antenna Installation

To install the DXi cellular antenna:

Insert antenna wires and threading through the hole (**Figure 8**).



Connect wire connectors to connectors in step 3 page 1.



For plastic pedestal, the wifi antenna is installed into a cutout in the lid (**Figure 9**).









FCC & IC Label

It is important to keep track of what wireless devices are installed in your DXi controller.

Each DXi controller ships with a label showing important information such as Model number, Serial number, UL certification, and more

Depending on the enclosure, this label might be found on the interior side of the enclosure door **2**

- If your DXi controller ships with a wireless device, the label will show the FCC ID and IC ID (1).
- If your DXi controller does not ship with a wireless device, the label will be blank in that area.

The cellular kit ships with a small sticker label with its FCC ID and IC ID 3.

- If your DXi controller label is blank in that area, adhere the FCC sticker to that blank area.
- If your DXi controller label already has FCC ID and IC ID information in that area, adhere the FCC sticker adjacent to it as illustrated **4**
